Brentwood Hills completed the upgrading of our exterior monuments in March. This project has been a focal point of the HOA for several years. The monuments are designed to give a newer appearance to our community.

The large oaks behind the Valrico Road (North) and Lumsden Road monuments were kept as part of the overall



presentation the HOA wished to preserve. The mounds will eventually be covered with jasmine, accenting the oaks and providing a maintenance-free area.

"Deed Restricted - No Soliciting" signage was placed at each entrance as the final stage of this project. Additional lighting has been suggested to further highlight the new monuments. That will be considered in the near future.

## **County Enforcement of Commercial Vehicles**

**New Monuments Project Completed** 

At the recent General Membership Meeting, several questions/ comments came up about the enforcement of commercial vehicles parked/stored within Brentwood Hills. Hillsborough County Code Enforcement will address vehicles meeting these criteria:

 Trucks or trailers that can carry more than 1 ton and were designed or modified for, and are

being used for, commercial use cannot be stored in residential areas, whether they are

marked with business decals or not.

 Abandoned or wrecked vehicles, or those missing doors, wheels, or other items that would allow the vehicle to operate in a safe and normal manner cannot be stored in residential areas.

- Vehicles with registrations expired by more than 90 days, missing tags, or tags registered to other vehicles may also be subject to investigation. [Hillsborough Code 09-63].
- Automobile, truck, boat, or aircraft

parts cannot be stored outside.

#### STUDENT DROP **OFF/PICK UP** ZONES

### Pool Key is A MUST to Use the Pool!

If you forget your pool key you will be asked to go home and return with it. If you have lost your pool key you will be asked to provide prior documentation and a check or money order for \$20 for a replacement key before entry will be granted.

If your pool key has been disabled/does not work, you will need to speak with an attendant and find out why. You MUST follow the proper steps to resolve the issue before access is granted for the pool.

### **Scheduled Pool Party Procedures**

Residents MUST stay with your party if you are the member booking the party. All deposits MUST be presented at the time of booking. You may show up 30 minutes prior for set-up. Please, NO EARLIER THAN THIS. You MUST be cleaned up and have your guests leaving the facility before your end time.


